- Parade starts at 3:00 pm, Saturday, December 3, 2011

Staging area will be set up on East Gold Street from Cherokee St. (City Hall) to Hwy 161. Your entry’s number will be on small signs on the westbound lane. Event organizers will be on or around the Cherokee/East Gold Street area (look for “Information” banner) and roving beginning at 2:00 pm (on Saturday) the day of the Parade.

Participants are reminded to “**TOSS**” their candy, not throw it. Additionally, please try to send the candy to the curb and sidewalk. Remember, kids love candy. Let’s keep it safe! Horses allowed only if diaper bagged.

Entries must be approved by the Special Events Director or City Manager before entry into the parade. No hoods or masks which cover the face will be allowed.

2011 CHRISTMAS PARADE
INDEMNITY AND HOLD HARMLESS AGREEMENT

This indemnification and agreement shall apply in all instances whether City of Kings Mountain is made a party to the action or claim or is subsequently made a party to the action by third-party in-pleading or is made a party to a collateral action arising, in whole or in part, from any of the issues emanating from the original cause of action or claim.
